The use of woods (nature) allows the	
individual to become attuned with his soul,	
the serenity of human life.	
Nature has the ability to allow the human	
being to experience the extremities of	
human emotion- life and death

Despair which threatens to overwhelm the human spirit- the speaker suffers despair and it entices it to suicidal thoughts, however the strength of the individual professes not to let despair overcome his spirit. He is still strong and determined in his journey despite his weariness of life, thus the capacity for endurance within the individual.	
The poem is an allegory for life- the need to enjoy what life has to offer and not be caught up in the day to day trappings.
